CONTRACTOR LICENSE RENEWAL APPLICATION

All Contractors' Licenses, General and Limited, will expire December 31st of each year. Licenses may be renewed by mail or when requesting your first permit of the new year. For subcontractors doing work within the City of Canon City your license must be acquired prior to beginning any work. **It is your responsibility to insure that a current Certificate of Insurance is on file with the City. Permits will be withheld until a current certificate of insurance is provided.** You may return the Renewal with a check, cashier's check or money order to:

The 2006 Editions of the International Building Code, International Residential Code, International Mechanical Code, International Fuel Gas Code, International Existing Building Code and International Energy Conservation Code were adopted by the City of Canon City and became effective September 1st 2008. The International Energy Conservation Code effective date was July 1st 2008 as set forth by State Statute. Copies of the amendments and deletions are available by request at the City Building Department. These codes continue to be in effect.

ICC exams are required for a General Contractor (Unlimited License), Residential Contractor (One and Two Family Dwellings and their accessory structures), Building Contractor (Three stories or less commercial and includes one and two family dwelling and their accessory structures) and Mechanical Contractor's License (Master or Journeyman). **Note these exams are not given by the Canon City Building Department. Exams are given at proctored testing locations. More information these examinations can be found on the International Code Council web site at www.iccsafe.org or by phone at 1-877-STD-EXAM or 1-877-783-3926.** Code books may be purchased on line at the ICC web site. If you do not have internet, I have an ICC catalog that I can run copies of order forms from.

✓ **NOTE:** Contractors that have allowed their license to lapse for a full 1 year cycle will be required to retest. The retest will be based on the current code edition adopted by the City of Canon City.
