General Government Committee: Typically, this committee addresses many of the "soft" services provided by the City, including finance, administrative policies, legislative policies or ordinances, etc. Held on the Wednesday after the Regular Council Meeting at 4:00 p.m.

Public Works Committee: Typically, this committee addresses items relative to infrastructure, such as water distribution, road construction, streets and parks departmental functions, infrastructure projects, water treatment plant, etc. Held on Tuesdays at 4:00 p.m. the week following that week in which a Regular Council meeting is held.

Purpose: Committee meetings are an opportunity for in depth discussion and explanation regarding proposed policies, legislation, etc. While the City of Cañon City has always referred to these as standing "committees", most other municipalities utilize some form of meetings such as this, calling them "work sessions", "planning sessions", etc. These meetings are not an effort to circumvent the political process and discussion at Regular Council meetings. Typically, these meetings provide an opportunity for staff to receive direction in developing policies, resolutions, ordinances, contracts, etc., for consideration at another committee meeting, or at regular Council meetings. It provides an opportunity for timely consideration of items of business for the operation of the City. It also gives an opportunity to determine if the item can be considered on the Consent Agenda, (due to the unlikelihood of debate) or direct the placement of the item on the Regular Agenda. No official vote or action is taken at Committee meetings.
