- Wedding Ceremonies are allowed on pedestrian bridges, but picnics or receptions are prohibited (Do Not Block Bridge).



Centennial (Duck) Park Pavilions



Rotary Pavilion is the largest of the pavilions and is closest to the playground and splash pad. There are 8 picnic tables that can accommodate up to 64 people. Rotary Pavilion is the only pavilion that has electricity.

Pavilions #1-3 have 2 picnic tables and can accommodate up to 16 people. All pavilions have bike racks and trash cans. There are no charcoal grills, however, users may bring their own portable gas grill or cooktop to use.

Pavilion #1 is closest to southeast parking lot, open grass areas, and duck pond.

Pavilion #2 is closest to the second larger whitewater play wave and the pedestrian bridge that spans over the Arkansas River; connecting to a very large parking lot north of the bridge/river.

Pavilion #3 is north of the northwest parking lot, first whitewater play feature, and boat put-in/take-out.

All decorations and tape must be removed from the area (tables, posts, overhang) and placed in the trash receptacles once the private event is over.
